The Natural Place for Business: A Natural Capital Investment Strategy

The Dorset LNP published its Natural Capital Investment Strategy in March 2016. The strategy outlines how the aspirations for Dorset laid out by the Dorset Local Enterprise Partnership (LEP) and in Local Authority plans can be achieved not just without damaging the natural resources on which our prosperity is built, but by enhancing them so that they become even more valuable to us in the future. It also aims to show how development, in addition to that described in the LEP Plan, can be achieved by taking a 'Natural Capital' approach that is suitable for Dorset to increase the quality of Dorset's assets and make them more resilient.

Algal Harvesting Workshop

A joint LNP, Local Enterprise Partnership and Poole Harbour Catchment Initiative workshop was held in December 2015 to discuss the potential for algal harvesting in Poole Harbour.

A CEFAS' report commissioned by the Environment Agency set out options for the removal of algae in the harbour, its uses and the likely constraints. The workshop provided an opportunity to allow stakeholders, including statutory bodies, local authorities, landowners and conservation organisations, to meet, discuss and share opinions on the ideas before any project proposals were developed. It also provided the opportunity to facilitate collaborative partnership working with a range of stakeholder representatives.

commissioned a study on
Dorset's Environmental
Economy from Ash Futures.
A stakeholder workshop

was held in October and the final study was launched at the LNP's Annual Forum on 25 February 2016. The study highlighted that Dorset's Environmental Economy is worth between £0.9 billion and £2.5 billion per annum and supports between 17,000 and 61,000 jobs in the economy. It is therefore worth between 5% and 15% of Dorset's overall economy each year.

Natural Choices Roll Out

Following the pilot project Natural Choices in Weymouth and Portland, the Dorset LNP is leading the expansion of the project to roll it out across Dorset.

Natural Choices aims to enable people to improve their physical health and mental well-being through a range of activities within the natural environment e.g. conservation activities, mindfulness and nature walks.

The project is working closely with the LiveWell Dorset team, commissioned by Public Health Dorset, who coach and sign-post people to activities to improve their health and wellbeing, including activities under the Natural Choices banner.

Square Meal Debate

Working with the Big Lottery funded Communities Living Sustainably in Dorset, the LNP helped to run event a debate on the Square Meal Report in October. The Square Meal Report was published by 10 UK organisations including the RSPB, Friends of the Earth, the National Trust, the Food Ethics Council, Sustain, the Wildlife Trusts, the Soil Association, Eating Better and Compassion in World Farming working with the Food Research Collaboration. The Report focused on four key inter-connected areas and proposed solutions for: improving health; good food for all; sustainable farming; and enhancing nature.

The debate in Dorchester brought together over 100 people to discuss the issues. A working group is developing an action plan to take the discussion forward.


Strategic objective vi:
