#### INVEST IN DORSET'S NATURAL ASSETS

### **Supporting the Dorset Local Nature Recovery Strategy and Annual Forum**

Dorset LNP began supporting Dorset Council (the Responsible Authority), Bournemouth, Christchurch and Poole Council (the Supporting Authority) and Natural England in the development of the Dorset Local Nature Recovery Strategy (LNRS) in summer 2023. Dorset LNP was invited to chair and facilitate a Nature, Farming, Forestry and Land Use Expert Group and began hosting monthly meetings in October 2023.

The 2024 Annual Forum was an all-day event focusing on the development of the LNRS. Over 120 people attended from a wide range of stakeholders including environmental charities and organisations,

non-governmental organisations, the two local authorities, farmers and landowners, parish councils and community groups. The event heard inspiring presentations from a range of nature recovery projects including as those funded by the Landscape Recovery Scheme (part of the government's environmental land management schemes). A series of workshop sessions engaged attendees to inform the development of the LNRS.

#### ADDING NATURAL VALUE TO THE LOCAL ECONOMY

#### **Nature South West**

Dorset LNP represented the county at discussions investigating the potential development of a regional partnership to support large scale investment through green finance from private and public sector funds under the banner of Nature South West. The proposal led by Natural England and National Landscapes (formerly Areas of Outstanding Natural Beauty), looks to follow a model created as Nature North. The Dorset LNP Manager joined a Steering Group and joined a stakeholder workshop in the autumn to discuss the scope and feasibility of developing the partnership (or organisation) and investable propositions across the region.

### **Health and Nature Dorset (HAND)**

Following focus groups and arts-based workshops held between February and June 2023 HAND published its Barriers into Nature Connection report in November 2023. The report focused on the barriers people with long term health conditions which stop them connecting with nature.

The report will shape HAND's future work and has been used to support funding bid by partners.

In January 2024 HAND hosted its first members workshop on the theme of communication. The aim of the workshop was to bring HAND members together to share experiences and discuss potential opportunities for joint working. The communications sessions discussed the messages organisations were using to share the benefits of nature-based wellbeing and sought to look for common approaches that could be shared.

The LNP Manager also presented at the Dorset Conference of Parties (COP) in September 2023, jointly hosted by Dorset CAN (Climate Action Network), Sustainable Dorset and Zero Carbon Dorset and the LNP Board endorsed the Dorchester Declaration developed at the event.

### **Improving Communication**

The Dorset LNP X (formerly twitter account) was set up in November 2015 @dorset\_Inp. In March 2024, the account had 713 followers (up 31 over the year).

E-news bulletins were published in December and February. In March 2024 there were 448 Forum Members (up 78 over the year).

Dorset LNP raised its profile through presentations on its work to: Dorset Local Enterprise Partnership's One Health conference (July 2023); and Kent Green Social Prescriber Group (July 2023).

The LNP's communication tools help promote the work of the LNP and its partners and helps engage with new audiences.

### SeaHives: Innovative structures that help create and restore marine ecosystems

SeaHives are shelters designed to provide refuge for marine animals, somewhere to live, grow, breed and thrive thereby increasing the total diversity and density of marine life in a local area.



The concept was born from the experience of SeaHiv designer and keen diver Davis Francis. Diving around the UK and overseas he saw first-hand the damage caused to the arine environment by scallop dredging, explosive fishing and mangrove deforestation. But he also noted, in locations such , Libya, Scotland and Papua New Guinea how hard surfaces when orientated to a flow of plankton laden water, quickly become colonised by filter feeding animals, thereby initiating
