FOREWORD

It's always a privilege to write a foreword to Dorset LNPs annual report, before the evidence of how we have brought people together and enabled the development of partnerships to support and develop the opportunities for nature and our engagement with it in the beautiful county of Dorset. For example, our annual forum was a great success, bringing together a range of people and enabling new thinking on how we can both support nature, but also our own well-being.

This year marks a major reformulation of our strategic plan. Like all good plans, this will be a live document, evolving and developing over time. We do not intend for this to sit on shelf and gather dust. We can't. The world is facing a triple crisis, all of which are caused by humans and the way in which we have lived upon the planet, and which have accelerated dramatically since the industrial and agricultural revolutions. The immediate and pressing impacts of climate change, biodiversity degradation and a wider health and wellbeing crisis are interlinked, and as such we intend to work within, and between these priorities over the next few years.

We cannot exist without nature, we exist within it – if we are not ensuring that the sustaining connection is maintained and cherished, and the foundations upon which it is built are supported, we are in trouble. Humans are in the process of creating a situation where the intrinsic importance of the natural world is being forgotten. This is not a sensible approach! We need to work, play, and co-exist far more harmoniously with the natural world around us.

Dorset LNP exists to support, facilitate and enable the working of a range of bodies across the public, private and third sector to improve nature, and address the challenges above. In doing so we act as a conduit for a range of parties including Local Authorities, Healthcare Services, Land Management and others to find the best way forward as co-collaborators in nature-based solutions.

It our aim to act on all three challenges thinking globally but acting locally. Our focus is to ensure Dorset is a place where nature thrives, and so do we.

We do all this with no direct funding from government but because of the much appreciated support from member organisations who see the value of a collaboration for the environment we continue our work. 
Strategic objective i:

ADDING NATURAL VALUE TO THE LOCAL ECONOMY

The Great South West

The Local Enterprise Partnerships and the local authorities in the region have been working to develop a prospectus for The Great South West with the strapline of 'The UK's Natural Powerhouse'. The Great South West aims to deliver £45bn of economic benefit and become the leading region for the green and blue economy.

Luke Rake, Dorset LNP Chair, is leading a sub-group of the GSW board to consider Rural, Food, Farming and Fisheries, with the aim of developing an 'ask' to

central government to enable resilience in these economic areas. The role of LNPs within this ask has been made explicit, and a draft proposal has been placed before the GSW board in July to create a Rural Economy Office, to act at scale across the region and enable coherent policy and investment development.

Following discussions with the GSW board, further work is planned over the summer of 2023 to now create a detailed model to enable discussions with DEFRA to occur in the Autumn.

HAND ran a nature-based wellbeing programme for the Integrated Care System ICS (those working in NHS Trusts,

social care, primary care and the unitary councils – BCP and Dorset). A wide range of activities were held, including yoga and Tai Chi in parks, forest bathing, pony handling, arts in nature, wellbeing walks in nature reserves, and archaeological walks.



Low Carbon Dorset Panel

Dorset LNP continued to be the assessment panel for larger-scale bids to the Local Carbon Dorset programme to ensure transparency. One panel meeting was held during in June 2022, as the programme came to an end. Funding was granted to the one project assessed. The project was expected to deliver the outcomes below:



Objective	Measurable output
Increasing the amount of renewable energy capacity in Dorset	0.160 Mega Watts (MW)
Reducing greenhouse gas emissions	43 tonnes CO2e per annum
Grant funding approved	£302,082.00
Total project costs of projects approved	£755,205.00

Improving Engagement: Dorset's Nature Young Journalists

Working with Dorset Wildlife Trust and Participation People (a national Youth Voice organisation) we ran a Young Journalist programme, training a group of eleven 14-18-year-olds from across Dorset in journalism skills with a focus on environmental issues. The project was funded through the Nature Heals programme from the Fine Family Foundation. The project raised awareness in the group of the climate and ecological emergencies and gave a greater understanding of the wellbeing benefits nature can give. A blog and three podcasts were produced by the Young Journalists.


